IT IS THE BACKBONE ORGANIZATION FOR THE MO-503 CONTINUUM OF CARE WHICH IS A CROSS-SECTOR COALITION OF HEALTH AND HUMAN SERVICE ORGANIZATIONS IMPLEMENTING A STRATEGIC PLAN TO END HOMELESSNESS. IT CONDUCTS THE ANNUAL POINT IN TIME HOMELESS COUNT, AND PROVIDES THE HOMELESS MANAGEMENT INFORMATION SYSTEM THAT TRACKS CLIENT SERVICES AND PROGRAM OUTCOMES.
